Eyelash Extension Services

Our eyelash extensions are already curved and come in six different sizes and thicknesses for you to choose from. Whether you like them thin and natural, long and dramatic, or thick and lush, we have eyelashes for every style.

FREQUENTLY ASKED QUESTIONS

What should I do before my appointment?

1. Remove all eye makeup and clean your eyelashes with mild oil-free cleanser. Do not use any oil based makeup remover.
2. Do not use any mascara.
3. Do not curl eyelashes, straight ones work better.
4. If you wear contact lenses, please remove them prior to treatment.

How is the lash extension performed?

The synthetic eyelashes are applied using a special bonding agent to each of your own individual eyelashes.

Can I use an eyelash curler?

No, a curler is too harsh on the eyelashes and will break the bond.

Can I use mascara?

Novalash is the only mascara that can be used on lash extensions, it is formulated in a way that it will not compromise the lash adhesive.

Are the extensions glued to my skin?

No, the extensions are glued onto your natural eyelash, about 1 mm away from your skin. Neither the synthetic nor the glue ever comes in contact with your skin.

Is the glue odorless?

Absolutely, burning and tearing do not usually occur.

What should I do after the appointment?

1. Avoid getting your eyelashes wet for the first 24 hours after the extension.
2. Avoid swimming, steam rooms and hot saunas within the next 48 hours.
3. Do not use an eyelash curler or tint since this will break the bond.
4. If wearing mascara, Novalash is the only mascara that can be used on lash extensions, it is formulated in a way that it will not compromise the lash adhesive.
5. Use only non-oily, non-creamy cleanser to remove makeup.
6. When cleaning, do not rub your eyes too hard.
7. Do not attempt to remove any extension eyelashes yourself.
8. It is safe to groom extensions so we recommend using an eyelash comb to straighten any stray lashes.

Why do you recommend retouching every 2 weeks?

Naturally you lose 1 or 2 eyelashes every day, but normally you won't notice them missing because your natural eyelashes are not very thick. However, with eyelash extensions you'll notice when they fall off right away because they are much thicker and longer than your natural eyelashes. When a new eyelash grows in it is time to touchup your eyelash extensions. Some people come in once a week because they prefer a full look at all times, but we recommend coming in every 2 weeks to maintain the lash extensions.

How do you remove eyelash extensions?

Please do not attempt to remove them yourself, since the glue is very strong. You'll have to get them removed professionally in the spa or wait for them to fall off on their own, which can take up to 2 months.

The longevity of the eyelash extensions depends on how well you take care of them. The maintenance depends on you; therefore, we cannot guarantee how long they will last. We recommend having a touchup every two weeks.
